Iowa Public Information Board Executive Director Eckley:

Jasper County, IA Attorney Scott Nicholson responded with the following regarding the evidence of his historical position toward disregarding numerous public records requests. At the same time, the evidence shows the Iowa Public Information Board disregarded numerous properly formatted complaints against Jasper County, IA, during 2023 and 2024 submitted in accordance with Iowa Code Section 23.7 (**Note:** Public records indicate that Iowa Public Information Board Executive Director Erika Eckley during this time was conspiring with Jasper County, IA, regarding false allegations of harassment. At the same time, the evidence shows the Iowa Public Information Board augmented this malicious allegation supported by zero evidence with evidence of service-connected mental health disability discrimination.)

"Back in 2023, Michael Merritt made an open records request to Jasper County, Iowa for emails concerning Iowa State Representative Jon Dunwell. Ryan Eaton contacted Mr. Merritt via email on August 4, 2023 (attached) and explained that Jasper County has previously provided requested records at no cost. Mr. Eaton further explained the costs related to prior and current request.

Most importantly, Mr. Eaton specifically stated that no further records requests would be reviewed until Mr. Merritt paid Jasper County for the Dunwell request."

The below link provides evidence of Jasper County, IA, Attorney Scott Nicholson responding to a public records request in the weeks after Eaton's 04 AUG 2023 electronic mail. At the same time, providing evidence that he lied in his 08 NOV 2022 and 09 NOV 2023 communications with the Iowa Public Information Board during case 22FC:0091. (**Note:** The referenced records request regarding Jon Dunwell was electronically served to Jasper County, IA, on 03 MAR 2023 (see attachments). At the same time, the evidence shows Jasper County, IA, failed to provide a requested fee for this records request in time frames articulated in Iowa Code Section 22.8(4.)(d.). This is consistent with the evidence that shows, as of today, Jasper County, IA, has still failed to provide historical public records representing this alleged fee that were requested on 13 APR 2023.)

The historical record of evidence shows that my statewide records requests in 2023 (that the Iowa Public Information Board produced evidence of criminalizing and discriminating against) were for the purpose of collecting a test bed of data to lawfully dispute Jasper County, IA's responses to my record requests. The evidence indicates the Iowa Public Information Board has historically allied with Jasper County, IA, while disregarding complaints filed in accordance with Iowa Code Section 23.7, spreading false allegations of criminal conduct, false hysteria, and disability-based discrimination. At the same time, the historical evidence shows the Iowa Civil Rights Commission completely disregarded all evidence, including published reports in the Iowa news, including the following quote:

"Pottorff responded by indicating Merritt's actions were "probably related to his mental health issues" and suggested Eckley consult with the Iowa Department of Public Safety."

I respectfully submit Executive Director Eckley: Why should I be in a position to believe or understand that Jasper County, IA, is no longer responding to my public records requests? At the same time, the evidence shows Jasper County, IA, released public records weeks after unethically proclaiming they would no longer respond to my public records requests in an email that was sent by an unethical and malicious Jasper County, IA, employee that was requested to halt contact due to the evidence supporting his criminal conduct against myself (Iowa Code Section 708.7(1)(a)(4)).

The evidence supports the conclusion that Jasper County, IA, Attorney Scott Nicholson, and Ryan Eaton are unethical alleged public servants that victimize the innocent. At the same time, they utilize the political power of their positions to hide from proper accountability for their historical acts. At the same time, the evidence shows that Jasper County, IA, Attorney Scott Nicholson deployed Ryan Eaton in the months after he lied to the Iowa Public Information Board in his 08 NOV 2022 and 09 NOV 2022 electronic mail (possibly in the hope of providing himself with an Iowa Rules of the Court Chapter 32 abstraction layer to shield himself from the evidence of future unethical conduct).

The longer the State of Iowa produces evidence of concealing Truth, the more evidence the State of Iowa produces supporting its violations of our laws. At the same time, the State of Iowa produces evidence supporting a continued historical posture of discrimination toward mental health disabilities. The incompetence within the leadership of the State of Iowa (that manifests evidence of unethical acts) is revealed within the evidence that indicates some believe they are still in control of this situation by simply ignoring emails, concealing requested records, disregarding complaints, and spreading false allegations of criminal conduct.

The evidence supporting Iowa Governor Kim Reynold's posture of discrimination toward mental health disabilities is provided by the facts that show the citizens she appointed directly or indirectly that manifested this statewide clusterfuck of injustice still maintain their tax-funded positions at the Iowa Public Information Board.

Iowa Public Information Board Executive Director Eckley:

Attached is the correspondence you requested.

Jasper County, IA, will not be receiving any future record requests from me for the following two reasons:

1. I believe the evidence supports the conclusion that I am never going to get the truth from Jasper County, IA, Attorney Nicholson, regardless of how long I pursue the Truth.
2. I have grown tired and fatigued of having to deal with the evidence showing Jasper County, IA, Attorney Nicholson's office's use of false allegations of criminal conduct as possibly a tool of oppression and intimidation against those the evidence indicates they victimize.

I am certain you are tired of disregarding the complaints I have sent you regarding Jasper County, IA, and then having to cover those numbers up in your Iowa Public Information Board annual reports.

This is how I suggest we proceed forward:

1. Jasper County, IA Attorney Nicholson can either provide a copy of the record request and historical documentation of the fee that I allegedly failed to pay, which I will most likely be able to dismantle with statewide evidence from similar-sized Iowa government bodies that use Microsoft 365. Or,
2. Jasper County, IA Attorney Nicholson can provide the requested Microsoft 365 billing data public records showing tax-funded seats (quantity of licenses), which, I believe, will assist me with dismantling Nicholson/Eaton's historical assertions in their public record request responses (historical fees/time invested). Honestly, provided the evidence that suggests both (Nicholson/Eaton) will lie and spread false allegations of abuse and multiple forms of criminal conduct, why should we believe their assertions regarding public records fees?

I have delayed my complaint against Nicholson as I am waiting for certified court documents from the State of California to provide evidence to the Iowa Court supporting Nicholson/Eckley were involved with Claudia J. Merritt and other conspirators in the spread of false allegations of abuse not supported by evidence against myself while facilitating the spread of false allegations of criminal conduct against me across the State of Iowa. I am also in the process of acquiring medical records to provide evidence of the trauma this has caused me.

Iowa Code Section 706.1(2.) communicates the following regarding conspiracy, "2. *It is not necessary for the conspirator to know the identity of each and every conspirator.*"

Iowa Code Section 706.1(1.) communicates the following, "*A person commits conspiracy with another if, with the intent to promote or facilitate the commission of a crime which is an aggravated misdemeanor or felony,...*"

I believe the evidence I have of mental health damage that evidence indicates is directly related to these events will meet my understanding of the requirements of Iowa Code Chapter 708 (aggravated misdemeanor or felony) and other Iowa Code references that I provided to Jasper County, IA Attorney Nicholson, in 2022, and I believe in December 2021.

I am respectfully requesting written apologies from those that the evidence supports spread false allegations of criminal conduct supported by zero evidence against me on a signed affidavit declaring that this behavior has halted and will not continue in the future so that I may continue my life in peace.

I am respectfully requesting your government body's most recent monthly billing receipt with Microsoft 365, Google Workspace, or other vendors providing information system licensing and the quantity of users licensed by your government body.

I am going to correct the evidence of unethical conduct that some have manifested evidence supporting regarding fees that are not consistent with Iowa Code Section 22.3 so that the State of Iowa is no longer able to victimize future Iowa citizens.

Fact: Iowa State University, University of Iowa, and University of Northern Iowa completed all of my previous record requests for \$60 or less.

Fact: These universities have tens of thousands of users that these searches were conducted on.

Fact: These universities have reported information system licenses and quantities.

Thereby obsoleting any future Iowa government body with 100 or 300 end users with the ability of pulling 3 or 4 figure fees out of thin air for an identical search.

Fact: The originator of this record request has already uncovered nearly 1 half million in alleged fraud generated by the City of Marshalltown, IA through evidence supporting the City of Marshalltown IA's misrepresentation of their government body's Zimbra 8 and 9 mail server capabilities.

Fact: Public records are on hand showing dozens of Iowa Counties involved in the Iowa Public Information Board's alleged disability-based discrimination via a 2023 teleconference with the Iowa State Association of Counties.

Fact: Approximately 80 Iowa Counties Attorney's produced evidence of failing to respond to my January 2024 record request.

Fact: 1 Iowa Public Information Board Executive Director produced evidence of sweeping these complaints under the rug.

08 JAN 2025: Production of evidence of county attorney's violation of Iowa Rules of the Court Chapter 32 (See: [Iowa Rules of the Court Sections 32:4.4\(a.\) and 32:8.4\(a.\)](#))

To those who have answered my previous public record requests with compassion and honor it was my honor to serve you. At the same time, it is those few that have preserved my faith in this nation.

I am committed to protecting and defending the rights and liberties of those I have served for twenty years of my life. The evidence showing the State of Iowa's discrimination against me, unethical attacks, and criminalization are irrelevant. It is impossible to cause further damage to someone or take anymore away from those who have nothing left to live for except the hope and prayer that light will shine in the morning.

Director Eckley,

Back in 2023, Michael Merritt made an open records request to Jasper County, Iowa, for emails concerning Iowa State Representative Jon Dunwell. Ryan Eaton contacted Mr. Merritt via email on August 4, 2023 (attached) and explained that Jasper County has previously provided requested records at no cost. Mr. Eaton further explained the costs related to prior and current request.

Most importantly, Mr. Eaton specifically stated that no further records requests would be reviewed until Mr. Merritt paid Jasper County for the Dunwell request.

To date, the Jasper County Auditor, IT Director and Attorney have not received any monetary payments from Mr. Merritt for the work previously done for him (Dunwell request).

On the IPIB website, there was a power point training called "Sunshine Laws." That training states that "Fulfillment of a request may be made contingent upon payment of a fee and estimated expenses shall be communicated to the requestor." (authority unknown).

In his August 4, 2023, response to Mr. Merritt. Mr. Eaton explained that there had been previous work done by his department (the Dunwell request) and those fees would have to be paid before any more work would be done, which would include Mr. Merritt's request for billing documents related to Microsoft 364, which is before the IPIB now.

Jasper County has a Public Records Request Policy. In that Policy, under the paragraph labeled "Advance Deposits" it states: "If any requestor has not paid a previous amount due under this policy, the County department shall require full payment of the previous amount due plus a full deposit for estimated services before processing a new request" (attached).

In summary, Michael Merritt has owed Jasper County fees for a previous request he made in 2023 and has not yet paid. Under Iowa case law and Jasper County Policy, Jasper County must be paid prior fees before any more public records requests will be reviewed that are made by Michael Merritt.

Mr. Merrit,

I have been tasked with reviewing your latest requests and I am afraid the Iowa Public Information Board already ruled for Jasper County, and we will not provide you with "user names" for Jasper County Facebook accounts.

The Supervisor's Facebook pages are their own and not administered or connected to Jasper County. You will need to address that with them.

I appreciate your confusion about the fees charged by different entities for E-discovery services. Indeed, the security requirements play a significant role in determining the cost. Organizations dealing with sensitive data like CJIS (Criminal Justice Information Services) have stricter security requirements, and therefore, they may need to more experienced and certified IT staff, which can lead to higher fees.

On the other hand, educational institutions, like schools, may not handle such sensitive data, so they can potentially use alternative, cost-effective solutions. Utilizing a paid intern or cyber security student to perform the E-discovery under supervision can help reduce expenses while still ensuring compliance with privacy regulations and removing personal identification information (PII) to protect individual privacy.

It's essential for organizations to understand their specific data security requirements and tailor their E-discovery approach accordingly. By doing so, they can strike a balance between cost-effectiveness and maintaining the necessary level of security.

As the only staff member with training and a license to use Gimmal's Discovery Attender for Open Records Requests, they are performed by me. You will find this in smaller departments where resources may be limited, it can be more costly for both the organization and the requestor.

The NIST (National Institute of Standards and Technology) framework or NIST 800-53 is widely used for information security and access control in various organizations and government agencies. The principle of least privilege is a fundamental concept in this framework, where each user or account is granted only the minimum level of access necessary to perform their specific tasks, reducing the risk of unauthorized access and potential security breaches.

Jasper County has implemented a process for searching and granting access to specific accounts, but this access is given on a temporary basis. The process involves the following steps:

1. Access Request: When someone needs access to a particular account or resource, they must submit a request.
2. Individual Permission: Each account is individually granted access based on the principle of least privilege. This means that users will only be given access to the specific resources they need and nothing more.
3. Processing: The access is granted and processed after business hours. The specific details of the access request and the time it takes to process are automatically recorded in a report.
4. Access Removal: Once the authorized user has completed their task, the access is removed. This ensures that the temporary access is not left open unnecessarily.

The time taken to process an access request varies depending on the size of the account. Accounts with larger data volumes (e.g., 25 GB) may take several hours to process, while smaller accounts may be completed in 30 minutes or less.

By implementing this access control process, Jasper County is ensuring that only authorized personnel have access to specific resources for the duration required, minimizing the risk of unauthorized access and potential security threats. Additionally, the logging and reporting of access times provide transparency and accountability for access-related activities.

MXtoolbox.com or dnsstuff.com can be used to view our Jasper County's MX records to see it is on Microsoft's Government Cloud. Again, as required by Federal Law, CJIS data must be stored within the United States and with ever increasing cyber-attacks, it is more cost effective to use third party security than attempt to protect it in house.

Previously we have provided approximately 40 hours of both IT staff and Attorney timelwages on your requests at no charge. It seems there was a misunderstanding, and any organization can bill for staff's time to complete requests. My wages increased on July 1st and the current cost at 1.5 for afterhours "time only" is \$83.35.

You will need to discuss the fees for the County Attorney's staff hourly rate to review the results and redact any Personal Identifiable Information (PII), Health Insurance Portability and Accountability Act of 1996 (HIPAA), Public Law 104-191, or Criminal Justice Information Systems (CJIS) protected data. That will be redacted according to Federal laws.

Based on your previous emails regarding building databases and the potential for collecting information contained in metadata on attachments, all requests will be printed and sent by certified mail to the address you have provided.

I have an outstanding open request from you for emails from Jon Dunwell to any jasper county email account. Per your request I included the cost per hour and received no confirmation that you accepted or would pay that fee. That will need to be paid for before additional requests are reviewed and completed.

County department head, requested records will be available for the requestor's review for a period of one week after notification to the requestor that the original public records are available for inspection and copying. If the requestor does not review the original public records within one week or make other arrangements with the County department, the requestor may incur additional charges for the additional time spent in the re-search, re-preparation or re-retrieval of the public records.

3. Other Applicable Fees and Deposits:

A. Additional Costs:

Any costs not covered by the above fee schedule shall be charged to the requestor based upon the actual costs incurred by the County department, including but not limited to all amounts charged to the County department by third parties in connection with the fulfillment of any public records request.

B. Advance Deposits:

If the County department estimates the fees for the requested services will be greater than ten dollars (\$10.00), the County department may require the requestor to make an advance deposit to cover all or part of the estimated fees. If a deposit is required, no work will begin on a request until the deposit is received by the County department. Any funds collected by the County department in excess of the actual fees will be refunded to the requestor in a timely manner. If any requestor has not paid a previous amount due under this policy, the County department shall require full payment of the previous amount due plus a full deposit for estimated services before processing a new request.

C. Cumulative Charges:

The charges outlined herein are cumulative to the extent they reflect the actual cost to the County department. For example, if a one-page black and white document takes 30 minutes to locate and the requestor wants the document copied and mailed, the charges will include charges for the 30 minutes of retrieval services, (.25 hours at staff rate), \$0.25 for the photocopy and the applicable postage charge for a certified mail delivery.
