AFFIDAVIT

STATE OF IOWA,

JASPER COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

From on or about August 17th, 2022 to on or about January 19th, 2023, the defendant did stalk the victim. The defendant engaged in the course of conduct after a protective order for relief from domestic violence was served on the defendant on 8/16/22, with the victim being the protected party of that order. The defendant's course of conduct included in part (non-exclusive list): repeated violations of the no contact order in person and through electronic and written means, harassment, burglary of the victim's residence, domestic assault, and maintaining physical or visual proximity to the victim without a legitimate purpose. The defendant has been convicted of violating the domestic violence protective order on 5 separate occasions between 8/17/22 and 1/19/23 with this victim of stalking being the same victim in all violations of the order. In addition to the above listed violations and convictions for violation domestic violence protective order constituting previous offenses, the defendant has engaged in 2 or more accompanying offenses including burglary 2nd degree, harassment 2nd, domestic abuse assault, false imprisonment, and obstruction of emergency communications which qualify as accompanying offenses for the purposes of stalking in the first degree. The defendant has caused the victim to feel terrorized, frightened, intimidated and in fear that the defendant will cause bodily injury to the victim, or the victims immediate family members, as the defendant's actions and course of conduct has increased in frequency and intensity and escalated over the course of time.
